ANTI-DUMPING NOTICE NO. 2017/21

Food Service and Industrial Pineapple Exported to Australia from the Kingdom of Thailand By Natural Fruit Co., Ltd

Findings in Relation to a Review of Anti-Dumping Measures

Notice under subsection 269ZDB(1) of the Customs Act 1901

The Commissioner of the Anti-Dumping Commission has completed a review, which commenced on 19 September 2016, of the anti-dumping measures applying to food service and industrial (FSI) pineapple (the goods) exported to Australia from the Kingdom of Thailand (Thailand). The review was limited to examining whether the variable factors relevant to the taking of the anti-dumping measures as they affect Natural Fruit Co., Ltd (Natural Fruit) have changed.

Recommendations resulting from that review, reasons for the recommendations and material findings of fact and law in relation to the review are contained in *Anti-Dumping Commission Report No. 373* (REP 373).

I, CRAIG LAUNDY, the Assistant Minister for Industry, Innovation and Science and Parliamentary Secretary to the Minister for Industry, Innovation and Science¹ have considered REP 373 and have decided to accept the recommendations and reasons for the recommendations, including all the material findings of facts or law set out in REP 373.

Under subsection 269ZDB(1)(a)(iii) of the *Customs Act 1901* (the Act), I declare that, for the purposes of the Act and the *Customs Tariff (Anti-Dumping) Act 1975*, that, with effect from the date of publication of this notice the dumping duty notice currently applying to the goods exported to Australia from Thailand by Natural Fruit is to be taken to have effect as if different variable factors (being the export price and normal value) had been fixed in respect of Natural Fruit, relevant to the determination of duty.

The duty that has been determined is an amount worked out in accordance with the combination of fixed and variable duty method, as outlined in the table below.

Particulars of the dumping margin established for Natural Fruit relevant to the fixed component of interim dumping duty is set out in the following table.

Exporter	Dumping Margin	Duty Method
Natural Fruit Co., Ltd.	9.6%	Combination of fixed and variable duty method which consists of a fixed (confidential) amount per kilogram (equivalent to 9.6 per cent of the ascertained export price) plus the amount, if any, by which the actual export price is lower than the ascertained export price.

To preserve confidentiality, details of the revised variable factors being the ascertained export price and the ascertained normal value will not be published.
